Dear Parents and Carers,

I hope you are all well.

As you are aware from my previous correspondence this week, we are contacting you with further information about Teacher Assessed Grades (TAGS's).

Exam Evidence

As part of the process for submitting grades, we are required to share with you the evidence that staff intend on submitting to the exam boards. The process for choosing evidence requires a number of factors. Essentially, the evidence used is required to be consistent across cohorts of students in their subject areas. This is subject to their set and tier of entry in certain subjects. This is to ensure that from an equality standpoint all students have had equal opportunities in producing work. Evidence will be standardised and moderated, both internally and in most subjects, externally with other providers.

We are providing a link to the evidence that staff are proposing to use to both make you aware, to be transparent and offer you the opportunity to let us know of any mitigating circumstances that you are aware of. These circumstances may have made your child not perform as well as expected when the pieces of work were being conducted. There are two links that follow:

1. This is the link to the evidence document on our website. It contains all the subjects and courses that students take across KS4 and KS5. Please have a look at it and scroll to the subjects that your child takes. You are asked to review the evidence being used for the subject and discuss this with your child.
